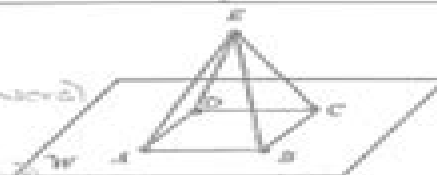

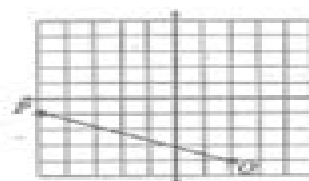

12. Find the coordinates of Z if Y is the midpoint of  $\overline{XZ}$ ,  $X(-10, 9)$  and  $Y(-4, 8)$ .

$$\begin{aligned} (-4, 8) &= \left( \frac{-10 + x}{2}, \frac{9 + y}{2} \right) \quad \leftarrow \text{midpoint} \\ -4 &= \frac{-10 + x}{2} & 8 &= \frac{9 + y}{2} \\ -8 &= -10 + x & 16 &= 9 + y \\ +10 &= +10 + x & -9 &= -9 + y \\ 2 &= x & 7 &= y \end{aligned} \quad \boxed{(2, 7)}$$
