Constitutionalism and Miscarriages of Justice Genevieve Lennon, Colin King, Carole McCartney, 2018-11-01 The purpose of this book is to honour the influential and wide ranging work of Professor Clive Walker It explores Professor Walker's influence from three perspectives Firstly it provides a historical reflection upon the development of the law and policy in relation to counter terrorism and miscarriages of justice since the 1970s This historical perspective which is often overlooked is particularly timely 17 years after 9 11 as trends become clearer and historical perspective even more valuable So too with miscarriages of justice while there was considerable public and political scrutiny following high profile miscarriages such as the Birmingham Six Guildford Four and others in the early 1990s today there is much less scrutiny despite significant concern relating to issues such as legal aid and access to justice increasing the potential if not likelihood for miscarriages to occur By including a critical historical perspective this book enables us to learn lessons from the past and to minimise contemporary risks of miscarriages

of justice Secondly this book provides a critical analysis of the law and policy as it stands today and its future trajectory Applying Walker's theoretical and analytical contributions to the field the authors focus on pressing contemporary concerns identifying lacunae where relevant as well as the possible probable and preferable future trends Finally the book celebrates and recognises the significant contributions by Walker with each chapter built around one or more of Walker's key works

Courts at War Gregory Burnep, 2021 On June 28 2004 the US Supreme Court broke with a long standing tradition of deference to the executive in wartime national security cases and became an important actor in an armed conflict By declining to rubber stamp the executive branch's actions the judiciary would henceforth play a major role in shaping national security policies in the war on terror After the September 11 2001 terrorist attacks lawyers lawsuits and court decisions have repeatedly altered the landscape in the policy areas of detention and military commissions In Courts at War Gregory Burnep explores how after 9 11 lawyers and judges became deeply involved in an armed conflict with important consequences for presidential authority the separation of powers and the treatment of individuals suspected of posing a threat to the United States Courts at War goes beyond the post 9 11 armed conflict It analyzes the changes in the position of courts vis vis the other branches of government courts in conflict with the executive the legislature or both even courts in conflict with other courts The consequences included increased checks on presidential authority and greater levels of due process for suspected belligerents held in US custody But Burnep also shows that there are unintended consequences that accompany these developments Burnep innovatively applies an interbranch perspective to persuasively argue that litigation and judicial involvement have important implications for changing patterns of policy development in a wide range of national security policy areas including surveillance interrogation targeted killings and President Trump's travel ban Special Advocates in the Adversarial System John Jackson, 2019-07-24 The last twenty years have seen an unprecedented rise in the use of secret courts or closed material proceedings largely brought about in response to the need to protect intelligence sources in the fight against terrorism This has called into question the commitment of legal systems to long cherished principles of adversarial justice and due process Foremost among the measures designed to minimise the prejudice caused to parties who have been excluded from such proceedings has been the use of special advocates who are given access to sensitive national security material and can make representations to the court on behalf of excluded parties Special advocates are now deployed across a range of administrative civil and criminal proceedings in many common law jurisdictions including the UK Canada New Zealand Hong Kong and Australia This book analyses the professional services special advocates offer across a range of different types of closed proceedings Drawing on extensive interviews with special advocates and with lawyers and judges who have worked with them the book examines the manner in which special advocates are appointed and supported how their position differs from that of ordinary counsel within the adversarial system and the challenges they face in the work that they do Comparisons are made between different special advocate systems and with other models of security
