Some of the key questions addressed include: Is the world running out of oil? And if so, is the cause physical scarcity or political policy failure? Why are many of the oil-producing countries in the developing world so unstable? Can oil markets be made to provide more stability to the world system? Part II examines some of the political responses to oil-related developments. Here the key questions concern the role of the political process in the development of alternative sources of energy. changing nature of the global political economy of energy and the European Union's response and the external dimension of the regulatory state. The book concludes that the EU's soft power has a hard edge which is derived primarily from its regulatory power. This works best when it targets companies rather than governments and it is more effective in the Near Abroad than at the global level.
