Options

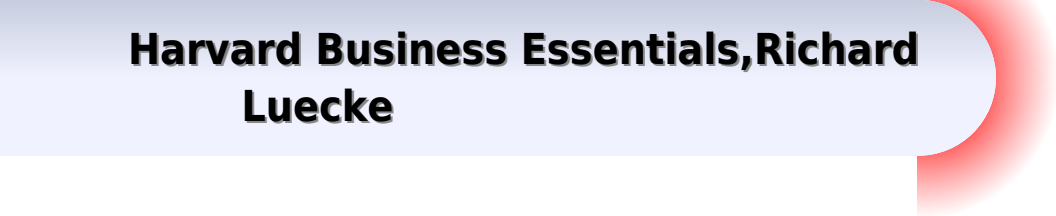
- Invent before deciding.
