- *To establish a valid contract, four elements are required:*
- *kesepakatan/the mutual consent of the parties; kecakapan/ a capacity to contract; hal tertentu/ a subject certain; sebab yang halal / a legal cause.(pasal 1320 KUH Perdata)*
- *Once the agreement satisfies requirements of valid contract, it becomes legally binding for the contracting parties. Pasal 1338 ayat (1) KUH Perdata: Perjanjian yang dibuat secara sah berlaku sebagai undang-undang bagi para pihak yang membuatnya. Pasal 1338 ayat (2) KUH Perdata: Suatu perjanjian tidak dapat ditarik kembali kecuali berdasarkan kesepakatan para pihak atau karena alasan yang dinyatakan oleh undang-undang.*
