Brown, 2010-04-01 When a handful of people thrive while whole industries implode and millions suffer it is clear that something is wrong with our economy The wealth of the few is disconnected from the misery of the many In Civilizing the Economy Marvin Brown traces the origin of this economics of dissociation to early capitalism showing how this is illustrated in Adam Smith's denial of the central role of slavery in wealth creation In place of the Smithian economics of property Brown proposes that we turn to the original meaning of economics as household management He presents a new framework for the global economy that reframes its purpose as the making of provisions instead of the accumulation of property This bold new vision establishes the civic sphere as the platform for organizing an inclusive economy and as a way to move toward a more just and sustainable world Greenbackers, Knights of Labor, and Populists Matthew Hild, 2010-02-25 Historians have widely studied the late nineteenth century southern agrarian revolts led by such groups as the Farmers Alliance and the People's or Populist Party Much work has also been done on southern labor insurgencies of the same period as kindled by the Knights of Labor and others However says Matthew Hild historians have given only minimal consideration to the convergence of these movements Hild shows that the Populist or People's Party the most important third party of the 1890s established itself most solidly in Texas Alabama and under the guise of the earlier Union Labor Party Arkansas where farmer labor political coalitions from the 1870s to mid 1880s had laid the groundwork for populism's expansion Third party movements fared progressively worse in Georgia and North Carolina where little such coalition building had occurred and in places like Tennessee and South Carolina where almost no history of farmer labor solidarity existed Hild warns against drawing any direct correlations between a strong Populist presence in a given place and a background of farmer laborer insurgency Yet such a background could only help Populists and was a necessary precondition for the initially farmer oriented Populist Party to attract significant labor support Other studies have found a lack of labor support to be a major reason for the failure of Populism but Hild demonstrates that the Populists failed despite significant labor support in many parts of the South Even strong farmer labor coalitions could not carry the Populists to power in a region in which racism and violent and fraudulent elections were tragically central features of politics Stunts of Late Nineteenth-Century New York Kirstin Smith, 2019-08-19 Stunts of Late Nineteenth Century New York Aestheticised Precarity Endangered Liveness examines the emergence of stunts in the media politics sport and art of New York at the turn of the twentieth century This book investigates stunts in sport media and politics demonstrating how these risky performances tapped into anxieties and fantasies concerning work freedom gendered raced classed bodies and the commodification of human life Its case studies examine bridge jumping extreme walking contests stunt journalists such as Nellie Bly and cycling feats including Annie
