In an academic setting the possession of title to inventions is expected to provide motivation for the university to license the technology to the private sector for commercialization in expectation of royalty payments. The Bayh Dole Act has been seen as particularly successful in meeting its objectives. However while the legislation provides a general framework to promote expanded utilization of the results of federally funded research and development questions are being raised as to the adequacy of current arrangements.
