La succession désigne la substitution d'un Etat à un autre sur un territoire donné. Elle résulte donc d'une mutation territoriale qui fait passer un territoire de la juridiction d'un Etat à celle d'un autre Etat.

De nombreuses mutations territoriales qui ont généré des successions d'Etat se sont produites lors de la décolonisation, le nouvel Etat indépendant succédant à l'Etat colonisateur. Mais d'autres se sont produites à l'occasion du démantèlement d'Empires (1919, turc et austro-hongrois) ou de dislocation d'États (URSS, Yougoslavie -1991- Tchécoslovaquie -1992-).

*The International Legal System in Quest of Equity and Universality* Laurence Boisson de Chazournes, Vera Gowlland-Debbas, 2021-10-18 Georges Abi Saab began his writing and teaching at a time when the process of decolonization and thereafter the quest for emancipation began to make its far reaching impact on the international scene producing significant changes in the international environment both quantitatively in increasing the number of nation States and qualitatively in changing patterns of interests and claims This was bound to result in new pressures on the international legal system itself and in a questioning of the traditional Eurocentric content of international law In his work and teaching Professor Abi Saab viewed the dynamics of international law as a function of two driving forces the emergence of the third world and the sense of injustice In his view the first driving force the emergence of the third world raised the problem of
