## HIPAA OMNIBUS FINAL RULE

The HIPAA Omnibus Rule was finalized by the OFFICE FOR CIVIL RIGHTS (OCR) and came into effect in March 2013.

It created the final modifications to the HIPAA PRIVACY and SECURITY RULES.

It included changes for enforcement, breach notification rules, and the Genetic Information Nondiscrimination Act (GINA).
