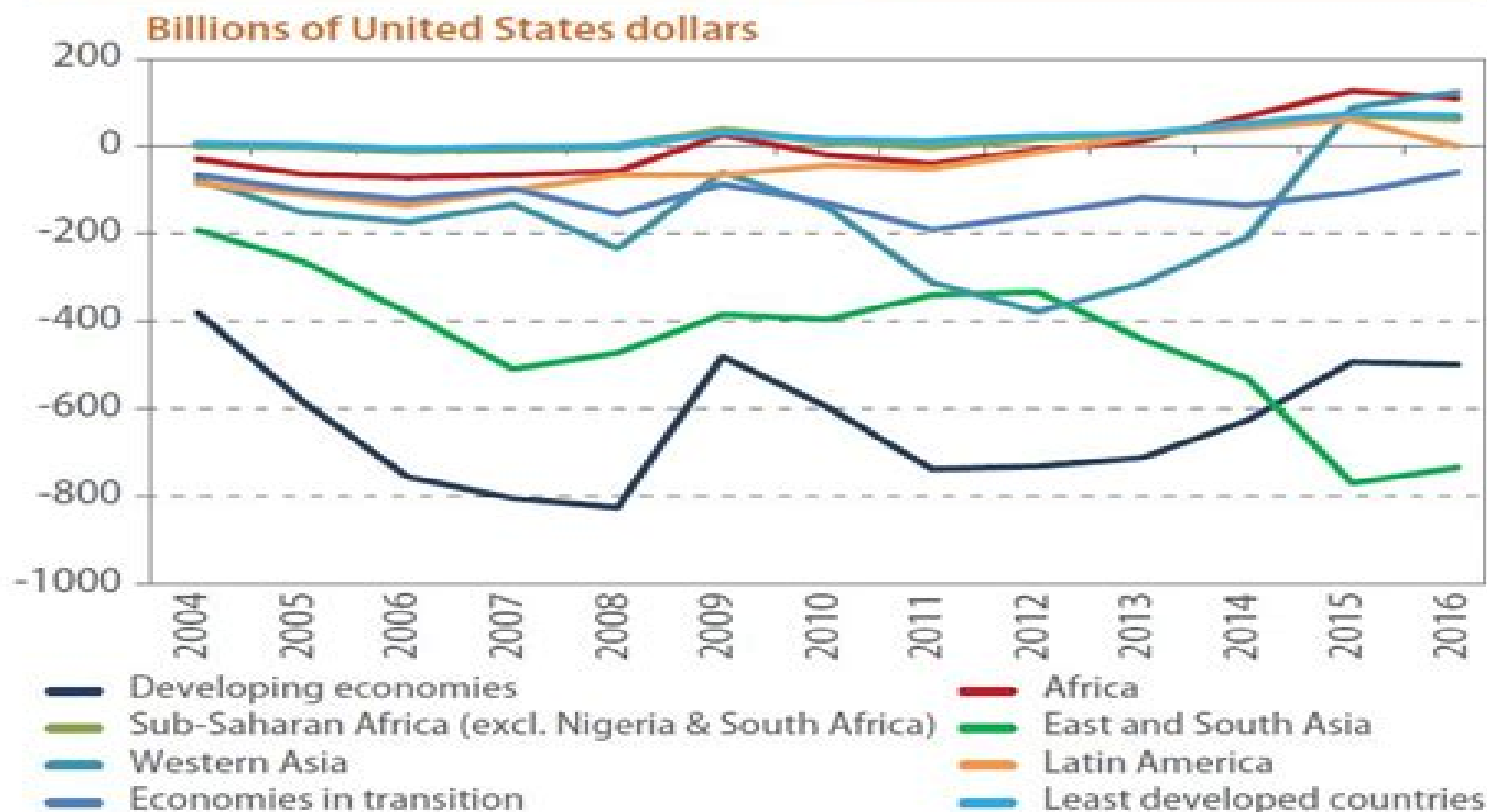

Net transfer of financial resources to developing countries and economies in transition, 2004-2016



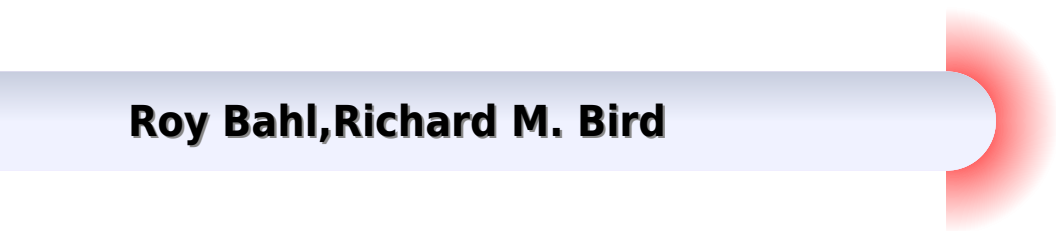
