- 2. Initiate legal actions to establish court order for support, paternity and/or residursement.
 - Prepare paternity complaint for custodial parents to sign.
 - b. Prepare appropriate legal documents and worksheets for review and signature of the County Attorney in accordance with gathered information, child support audelines, and statutes.
 - Set hearing dates.
 - Deliver and/or mail legal documents to Sheriff's Department or private Process.

- Initiate and respond to interstate actions with other jurisdictions outside of the State of Ationesota to gain compliance with court orders.

 - Prepare all recoverage documents to initiate an interstate action.
 - Respond to the interstate actions by takin administrative enforcement remedies to prompt compliance or to negotier an order with the court for further legal action.
