## New Georgia laws go into effect today

While Georgia's new hands-free driving law has attracted most of the attention when it comes to new state laws that go into effect today, there are plenty of other new laws that Gwinnett residents need to

keep an eye on.

An open door to tighter local restrictions on fireworks, and a new way for the state to collect unpaid toll fines and revised fines for passing a school bus stopped to pick up kids are some of the new laws that go into effect this week, end.

One of the big laws

now in effect may be the fireworks bill, House Bill 419, because it could mean about fireworks any day of the year atmosphere that has existed since fireworks became legal in Georgia in 2015 could be curtailed.

The bill lets cities and counties restrict fireworks use through general noise ordinances. The only ex-

ceptions guaranteed in the law are New Year's Day, the Saturday and Sunday before Memorial Day,

July 3, the Fourth of July, Labor Day and New Year's Eve.

Fireworks retailers must also post signs encouraging customers to check local ordinances before setting off fireworks and warning them that setting them off near military veterans or animals can trigger traumatic experi-

ences. Meanwhile, drivers who incur toll violations while using the E-ZPass Lanes on Interstate 85 could see any unpaid fines taken out of their state tax refunds. House Bill 150 lets the State Road and Tollway Authority collect on delin-

### Youth commissioners get look inside county government

As Lawrenceville youth Esther Ayiamasi strapped an oxygen tank to her back at the Gwinnett County Fire Academy in Dacula on Wednesday, she carefully

made sure she followed the directions from academy recruits exactly.

She and about 24 other Gwinnett County High School students also got to ride in a fire engine, use a fire hose to spray down the side of a scorched training building and learned how to

## 'Dancing Doctor' to face 2.5-year suspension

Gwinnett's "Dancing Doctor" has agreed to give up her medical license for at least two-and-a-half years, according to an agreement filed Friday with the Georgia Composite Medical Board.



Windell Bousie

certified dermatologist based in Lilburn, says that her license to practice medicine in Georgia is indefinitely suspended, but after two-and-a-half years she can petition to have the suspen-

sion lifted. She cannot use the title "doctor" or engage in the practice of medicine during her suspension, the document says, and will drop her own court case in which she seeks a temporary restraining order.

CNN has attempted to reach Bousie for comment on the agreement.

The consent order doesn't mention the now-deleted YouTube videos of Bousie during medical procedures. In one video, she dances with surgical instruments in both hands and beams over a patient's half-nude buttocks while rapping her own lyrics to "Rigga" by Lil Nas X and Blaqo.

The consent order, instead, describes seven instances of
