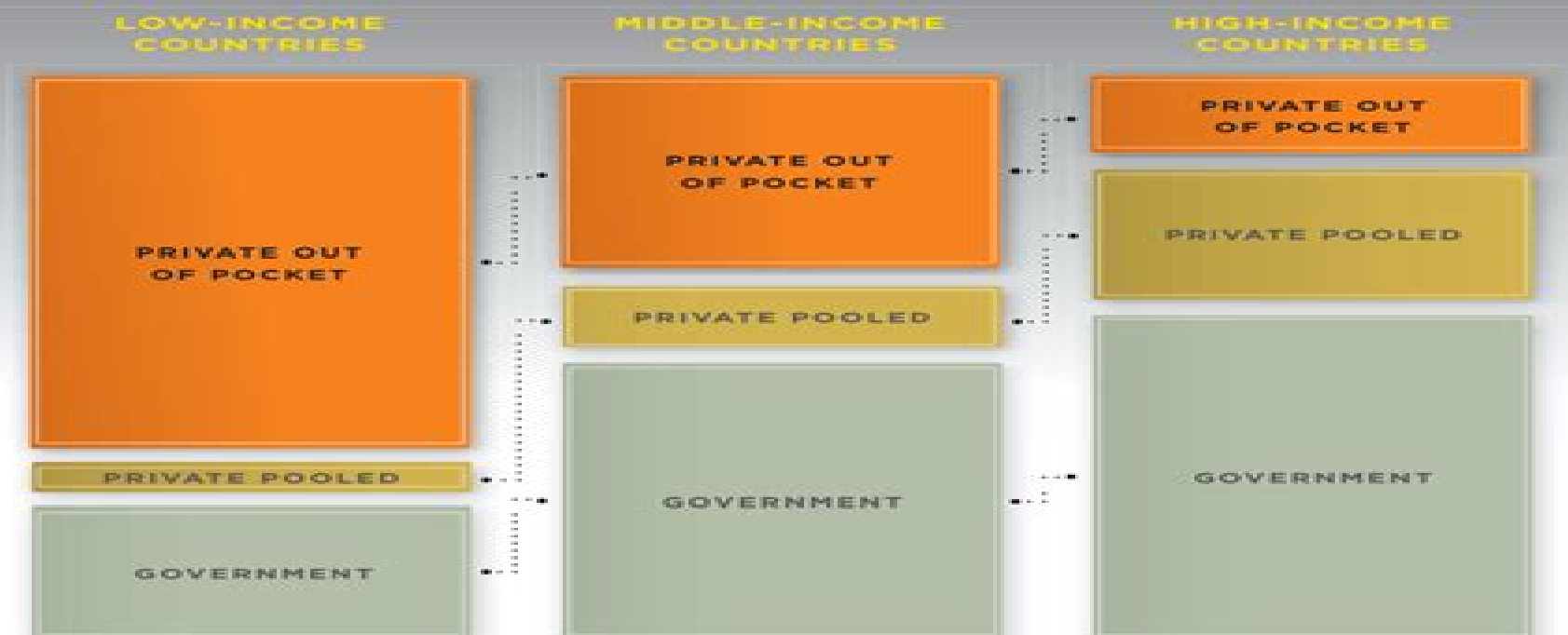

administrative structure how to address the current supply constraints to assure availability of promised services how to raise revenues to finance the system including the program for the poor as well as currently uninsured groups that may require government subsidization such as the more than 60 million informal sector workers the 85 percent of workers in firms of less than five employees and the 70 percent of the population living in rural areas
