Liquid Relations Dik Roth, Rutgerd Boelens, Margreet Zwarteveen, 2005-11-29 Water management plays an increasingly critical role in national and international policy agendas. Growing scarcity, overuse and pollution combined with burgeoning demand have made socio-political and economic conflicts almost unavoidable. Proposals to address water shortages are usually based on two key assumptions: 1. water is a commodity that can be bought and sold and 2. states or other centralized entities should control access to water. Liquid Relations criticizes these assumptions from a socio-legal perspective. Eleven case studies examine laws, distribution and irrigation in regions around the world including the United States, Nepal, Indonesia, Chile, Ecuador, India and South Africa. In each case, problems are shown to be both ecological and human-made. The essays also consider the ways that gender, ethnicity and class differences influence water rights and control. In the concluding chapter, the editors draw on the essays' findings to offer an alternative approach to water rights and water governance issues. By showing how issues like water scarcity and competition are embedded in specific resource use and management histories, this volume highlights the need for analyses and solutions that are context-specific rather than universal.

Water Security, Justice and the Politics of Water Rights in Peru and Bolivia Miriam Seemann, 2016-04-08 The author scrutinizes the claim of policy makers and experts that legal recognition of local water rights would reduce water conflict and increase water security and equality for peasant and indigenous water users. She analyzes two distinct top-down and bottom-up formalization policies in Peru and Bolivia: neoliberal and the former indigenist socialist. The policies have intended and unintended consequences and impact on marginalized peasants and the complex inter-legal systems for providing water security on the ground. A complex setting is unveiled that forbids one-size-fits-all solutions. Peru's and Bolivia's case studies demonstrate how formalization policies while aiming to enhance inclusion in practice actually reinforce exclusion of the marginalized.
