






In addition, various parameters have been studied to assess whether the regulatory systems follow the principles of good regulation in these nine states. The commercial loss without subsidy incurred by state power utilities increased from Rs 197 220 million in 2003-04 to Rs 221 290 million in 2004-05. In view of the huge losses being incurred by the utilities, the tariff determination function forms a central part of the reform process. A comprehensive survey of tariff orders issued by these SERCs for the distribution licensees has been undertaken to evaluate the effectiveness of regulatory orders in the electricity sector. It assesses whether the orders have resulted in reducing regulatory uncertainty and information asymmetry and better performance of the distribution utilities. However, tariff orders are only one index of effectiveness of the regulatory commissions. It is recognized that there are many other important functions of the SERCs besides tariff setting and some of them have also been covered in this study.
