

WOMEN'S 18 HOLE GOLF LEAGUE POLICIES AND PROCEDURES

1. ORGANIZATION - The Women's league may choose to elect an executive committee consisting of a President, Vice President, Secretary, Treasurer, and Member at Large. All positions would be 1-year terms. The executive board can appoint committees as needed. Examples of such committees would be Guest Day, Weekly Games and Ringer Score. League member votes may be conducted via electronic methods. No proxy votes are allowed.

2. EXECUTIVE COMMITTEE RESPONSIBILITIES - The Hayward Women's 18 Hole League Executive Committee shall consist of a President, Vice President, Secretary, Treasurer and Member-at-Large. The member-at-large shall be appointed by the President and serve a oneyear term. The Executive Committee shall recommend the amount of annual dues and prepare a budget for the league.

President: Shall preside at league meetings. In the absence of the treasurer, the president shall sign checks drawn on the funds of the league. She shall appoint committees as needed and coordinate activities to promote the smooth and efficient operation of the league.

Vice President: In the absence of the President, shall perform duties of the President, and if necessary, shall complete an unexpired term.

Secretary: Shall keep the minutes of league meetings, keep a record of league participants and handle correspondence of the league.

Treasurer: Shall collect membership dues and all monies due to the league. Shall sign all checks in payment of approved bills and shall report in writing the state of finances at the Spring and Fall league meetings.

Member-at-Large: Shall coordinate nominations for elections of the executive committee to be held at Fall Meeting and any other duties assigned by the President.

3. SPECIAL COMMITTEES

a. Pairings and Tee Time Committee -This committee shall use the Golf Genius Program to establish and post weekly pairings and tee times. The Pro Shop will assist as needed.
