1 What outcomes are we trying to secure for our pupils?

While schools are very likely to have a clear vision statement, and school development plan, you need to break this down more explicitly in terms of what you intend for pupils to learn.

When looking for evidence that intent is being translated to a balanced curriculum, leaders will see that from your highest statements, down to what this might look like in each subject, and for each age group.

Make sure you involve all staff governors, parents/carers and, crucially, the children. This isn't about daily lesson observations, but about a shared sense of purpose in the wider learning and how it holds together.

Be ambitious for all pupils, including those with special educational needs and disabilities (SEND), and consider how any end-of-stage progress is achieved by a collective progression.

2 Is everyone on board with our curriculum?

A key feature of the Ofsted Inspection Framework is that curriculum leads/governors, often an often middle leaders, are spending more time with the teachers that are doing it.

Ofsted looks at how well the school leadership team have understood and applied "values, policies and practice" to enable the intended outcomes to be achieved through each subject area.

The school leadership team includes governors and trustees who are responsible for leading the school and its leaders to ensure for the vision, strategy and quality of education in the school. Make carefully how you bring these stakeholders on the journey with you to make sure everyone is singing the same song.
