Shareholders' Rights and Duties Transactions requiring the approval of members

Context

So far in this Module, you have considered the separation of power between the ownership and management of a company and seen that the articles of a company give directors extensive powers to run the company on a day-to-day basis. Because a company's directors have day to day control of the company and its assets, there is always a risk of directors abusing this position when there is a conflict of interest between them and the company. The Companies Act 2006 makes directors subject to a series of 'general duties' which are intended to address this danger. As well as the 'general duties' in the Companies Act, there are special procedural rules which apply when a company is entering into a transaction with a director or where a director has some other sort of interest in what is being done. These offer the company and its shareholders some protection, but there are situations where these protections may not be adequate. In this Large Group, you will be concentrating on four types of transaction where there is a particularly serious risk of directors abusing their position. In these situations, the Companies Act 2006 imposes extra procedural rules to protect the company, and these have to be complied with before the transaction can be entered into.

4. Explain the consequences of failure to comply with these procedural rules
