Growing Use and Declining Perception of Risk

Prevalence: Marijuana is the most commonly used illegal substance in the U.S., and its use is growing.

Despite this increase, the perception of how harmful marijuana use can be is declining. More young people today do not consider marijuana use to be risky behavior.

Real Risks of Marijuana Use

1 Youth & Young Adults

There are significant risks for young people. Marijuana use during adolescence can interfere with brain development and lead to long-term cognitive issues. Additionally, those who start using marijuans develop an addition. 02

Pregnant or Nursing Women

Marijuana use during pregnancy can harm fettal development, leading to complications such as low birth weight premiature birds, and developmental to be passed to bables through breast milk, affecting their growth and development.

Brain Health & Loss of IQ

Studies show that marijuana can cause a permanent loss of up to 8 IQ points when use begins at a young age. These IQ points do not return, even after quitting marijuana.



Psychological Impact

Research links marijuana use to mental health issues, including depression, anxiety, suicidal thoughts, and psychotic episodes. It is not clear if marijuana causes these conditions, but there is a strong association.



Impaired Ability

Marijuana affects timing, movement, and coordination, which can harm athletic performance and increase the risk of injuries.
