License Grant

Subject to the terms and conditions of this Agreement, Licensor hereby grants Licensee a non-exclusive, non-transferable, non-sublicensable, limited license to use the Software, solely for Licensee's internal business purposes.

Restrictions

Licensee shall not (a) sublicense, rent, lease, lend, or otherwise distribute the Software to any third party; (b) reverse engineer, decompile, disassemble, or otherwise attempt to derive the source code for the Software; (c) modify, adapt, or create derivative works based upon the Software; or (d) remove, alter, or obscure any copyright, trademark, or other proprietary notices on or in the Software.

Intellectual Property Rights

Licensor shall retain all right, title, and interest in and to the Software, including all intellectual property rights therein. Licensee shall not acquire any rights in the Software, except for the limited license granted in Section 1.
