WHAT?

See the list of information to record in Part XII of the Health of Animals Regulations, section 154. Some of the information is the same as on a TOC and a provincial livestock manifest. Information already available does not need to be repeated.



Transporter writes the TOC and gives it to the abattoir, auction market or assembly yard. No special format (can be electronic). Recommendation: both parties keep-a-copy in their files.

Transporter completes record for each load of animals, keeps original (or a copy) onboard with the load, and keeps in files for at least 2 years. There is so special format (can be electronic)



WHY?

To ensure there is no gap in the responsibility for the animals. It is the transporters and receivers proof of what condition the animals are in, and when they arrived.

To ensure information about the animals' journey is available, and can be shared when needed, with everyone involved in humane transport.
