Medical Law

Lawyer: Regulated medical/legal issues within healthcare for better or worse **understand the relationship with professional regulation**

- Contractual relationship between and between healthcare professionals, agencies
- Federal and state governments regulate a professional and health care system
- State interventionism

Medical issues arise primarily in regulating health professionals and institutions: licensure, ethics training, professional codes - professional relationships, and interagency liability

- State regulation: insurance, managed care, medical-legal issues, public health programs

Philosophy: Moral considerations of technology in healthcare

- Different cultural differences in ethics
