

DISASSEMBLY OF AIR MOTOR

NOTE: All threads are right hand.

- Force the piston assembly up by pushing the (115) rod toward the top of the air motor.
- Remove the (155) muffler/(201) muffler assembly for ease of disassembly.
- Remove the four (138) socket head screws from the (140) head manifold and the one (138) socket head screw form the (122) head plate. Remove the (140) head manifold by pulling up and outward to remove from tubes (114) and (137).
