The main argument developed in this study is that the work of the MCSC for individual composers and lyricists is hampered by shortcomings in the regulatory regime as well as by a lack of members rights to participate in the management of their own rights and by the ineffective international cooperation between the MCSC and other musical CMOs overseas The analysis is undertaken through a case study approach comparing the collective management systems of music copyright in China the United States and Australia and addressing the question of how musical CMOs operate in these countries Specifically three perspectives are examined the regulatory systems designed to limit the misuse of those CMOs monopoly members rights in the organisations and international cooperation between these CMOs Overall the main findings of this book suggest that the MCSC in China could work more effectively to protect music creators interests In contrast although the operational frameworks of the American Society of Composers Authors and Publishers ASCAP and the Broadcasting Broadcast Music Inc
